### EU Regulations/ Company Mandatory Reports

From 2025, all companies in the EU with more than 500 employees will be obliged to submit an annual mandatory report on the status quo of their emissions and the environmental impact of their company to the tax authorities.

**From 2028, this will apply to all companies with 10 or more employees** (regulations and directives under the European Green Deal, ESG, CSRD, ESRS, SFDR and the EU Taxonomy Regulation).

The main objective of TransformIT Europe is to support the millions of companies in the EU on their path to climate neutrality in 2050.
